Bloomin' Barbeque & Bluegrass is a two-day event (May 18-19, 2012). Set up may begin at 11am and must be completed no later than 5pm on Friday, May 18, 2012. All arts and crafts vendors must remain set up until at least 9pm on Saturday, May 19, 2012. Security will be provided overnight, but we recommend that very valuable merchandise be removed when not in attendance. Vendors must be set up again by 10am May 19, 2012.

All applications for vending at Bloomin' Barbeque & Bluegrass will be reviewed. Please provide a photo or sample of your work if you are new to Bloomin' Barbeque & Bluegrass. For those selected, photos or samples will be returned on May 18, 2012. NO RESALE ITEMS ARE ALLOWED.

Artists and Crafters must provide their own table, chairs, tents, etc. for booth space.

Please submit this application, and a photo or sample of your art or craft to the above address no later than April 1, 2012 to pay the early entry fee of \$100 or between April 1 and April 15, 2012 to pay the regular entry fee of \$150. The committee reserves the right to reject any application. If your application is not accepted your money will be refunded. However, no refund of the application fee will be made once you have been accepted to vend at the Bloomin' Barbeque & Bluegrass festival. Any photos taken of your booth on site and your responses to questions in the application become the property of the Sevierville Chamber of Commerce and may be used for promotional purposes. Vendors agree to indemnify and hold the Sevierville Chamber of Commerce and its employees, volunteers and event sponsors harmless from any and all claims made against Bloomin' Barbeque & Bluegrass, including without limitation, all costs liabilities, judgments, expenses, damages or attorney's fees, arising out of or in connection with (I) Any structure erected by vendor, (II) any apparatus equipment or personal property used by vendor, (III) an act or omission to act of agents and (IV) any claims made on account or resulting from vendors participation in Bloomin' Barbeque & Bluegrass.
